Ghana: Soccer fans attack radio commentator

On November 8, 2009, a group of supporters of Real Tamale United (RTU), a football club in Tamale, capital of the Northern Region of Ghana, assaulted Kwabena Ntow, a reporter for Fila FM in Tamale and a correspondent for the privately-owned Peace FM in Accra for alleged biased reporting about their club.

Narrating his ordeal to Media Foundation for West Africa (MFWA), Ntow said the incident occurred at the Tamale Sports stadium, where he had gone to cover a league match between RTU and Wa All Stars.

According to the journalist, one of the supporters beat him up in the presence of the club secretary, Joe Harry Dua Baba, resulting in an injury to his chin.

"I was in the lobby of the dressing room to conduct a post match interview. It was at this time that one of the supporters confronted me and started to beat me up. They claimed I had been biased in reporting about the club. It was the chairman of RTU and the head coach Abdul Razak who came to my rescue by sending me into the dressing room."

The journalist alleged that in the dressing room, Dua Baba justified the action of the supporters by accusing him of biased reporting about the club.

When MFWA contacted Joe Kadil, chairman of RTU, he confirmed saving the reporter from the angry mob of RTU supporters. He added that the club has nothing against Ntow.

MFWA is urging the Tamale Central Police to immediately investigate the incident and quickly bring the perpetrators to book.

Zimbabwe: State broadcaster suspends employees for leaking information

Three employees with the state-controlled Zimbabwe Broadcasting Holdings (ZBH), O'Brien Rwafa, Jacob Phiri and Freedom Moyo, were suspended from their positions for 10 days after being accused of leaking information on a government directive to stop covering government ministers who were members of the Movement for Democratic Change (MDC-T) led by Prime Minister Morgan Tsvangirai.

Rwafa, Phiri and Moyo, who are employed as news editor, chief producer and bulletins manager, respectively, were suspended on full salaries pending investigations and were ordered to surrender ZBH property.

According to the weekly "Standard" newspaper in its edition of 8-14 November 2009, ZBH chief executive Happison Muchechetere refused to comment on the suspensions. Muchechetere was, however, reported as having earlier informed managers at the state broadcaster that all stories involving ministers from the MDC-T should be taken off air.

The investigations were so intense that the ZBH management board reportedly went as far as approaching a mobile cell phone operator to inquire into the number of phone calls made by the suspended managers.

Uganda: Govt Shuts Down Radio (and Weasel)

As elections approach, the government has shut down Radio and Weasel (also known as TV), accusing the popular singing duo of "inciting people" and "bringing hatred" against the government.

According to ear witnesses, the duo were unceremoniously shut down by the Bungling Council (BC), which is the government's electronic media watchdog.

"Apparently, the Bungling Council mistook Radio and TV for a real radio and television broadcasting station and shut them down after the Big Man complained that instead of going to attend his political rally at Yellow Square, people had voted with their feet and gone to Africana Hotel to listen to Radio and TV," said one ear witness, insisting that we must point out that we didn't hear this

story from him.

When the Big Man complained, according to the ear witness, the Chairman of the Bungling Council, Mr. Gofry Mutabaza rushed to Africana Hotel, unplugged and confiscated the singing duo's amplifiers and other electronic equipment, which he mistook for broadcast transmitters.

Intriguingly, the name Mutabaza translates as "shut the hell up" in some Ugandan languages! It's like his name earned him the top job at the Bungling Council.

"Mr Mutabaza said that Radio and TV were keeping people away from the Big Man's rallies with their irresistible songs, which amounted to incitement against the government, which is a treasonable act," said the ear witness.

Sources confirmed to The Analyst that people heading to the Big Man's rally at Yellow Square branched off to Africana Hotel to listen to Radio and Weasel instead when they heard them singing "Bread and Butter".

"I suspect people prefer bread and butter issues to abstract economic figures," one political commentator told The Analyst. According to him, some poor people might even have assumed that Africana Hotel was distributing free bread and butter.

The shutting down of Radio and TV follows similar actions against a number of radio stations which the government has accused of inciting violence, including CBS, Radio Two, Radio Suubi and Radio Sapientia.

It is not clear when, if at all, the Bungling Council will "re-open" Radio and Weasel.

Nigeria : Japan boosts Nigeria's Kaduna state radio reach

About nine months after it was handed over by the Japanese government, the Federal Radio Corporation of Nigeria (FRCN) Kaduna's 200Kw medium wave transmitter was commissioned at the Jaji transmission station yesterday. This is not the first time Japan is granting such aid to the FRCN, Barrister Yusuf Nuhu, the Director General said.

"I can be recalled vividly between 1989 and 1990, it extended to FRCN a 2.5 billion yen, which is equivalent to N1.5 billion grant in aid of our alternative power generating project", he said. The Director General also disclosed that work was presently going on in the second phase of the same project at the Enugu national station.

This donation, he further said, symbolized the mutual wish of both Nigeria and Japan to work together. Alhaji Halilu Getso, a former Zonal Director of FRCN Kaduna, praised the Japanese government for assisting the radio station. He however lamented that the commissioning was a day of sober reflection and not celebration. According to him, the station's Jaji transmitting station used to have 10 of such 200 mw transmitter that was being commissioned.

The former Zonal Director said the neglect of those in authority contributed to the collapse of the transmitters and the radio station was celebrating the receipt of one. Emir of Zazzau Alhaji Shehu Idris acknowledged the station's programmes, adding that radio was central to the Distance Learning Programme which the government had introduced.

Kenya: Kenya to form media content regulator

The government will form a Universal Content Regulatory Board which will control the content of broadcast material, the director of information has said. The board will incorporate the Media Council [of Kenya] and Media Owner Association under the ongoing amendment of the Kenya Communication Bill.

According to the director of information, Mr Ezekiel Mutua, powers vested on the Communication Commission of Kenya (CCK) had been reduced drastically. Mutua added that the controversial Section 88 of the bill which raised concern in the media fraternity would be deleted from the bill. "A meeting held between all the stakeholders in the sector and chaired by the prime minister agreed on these issues." The comments come a day after media owners accused the permanent secretary [PS] Ministry of Information Bitange Ndumo of malice as the government redrafts the act. During a meeting, the stakeholders said that the PS was determined to reintroduce the contentious issues that saw president Kibaki intervene. But Mutua moved in to defend his boss saying that the government was committed to press freedom.

"There is no space for dictatorship in Kenya and the government is not in a hurry to implement something not agreed by all stakeholders." He however called for responsible journalism adding that the media was free to criticize but they too should be ready for criticism.

Mutua was addressing the press in Morendat training and conference centre at the end of a five

day public policy course for senior government officers. Strathmore School for Business which organized the retreat said that course was meant to assist the officers provide way forward in policy implementation. According to Dr Carlos Sotz the university vice-chancellor, they would be expanding the facility located in Madaraka estate Nairobi.

Sierra Leone: NATCOM warns defaulting stations

The Sierra Leone National Telecommunications Commission has issued the following statement: The National Telecommunications Commission (NATCOM) would like to inform the general public that effective November 15 2009, all TV and radio broadcast stations in default of payment of their spectrum licence fees to NATCOM will face the full penalty of the law. This may include but not limited to closure of the station, confiscation of transmitter equipment or financial penalties up to ten times the licence fees.

All TV and radio broadcast stations are therefore advised in their own interest and in the interest of electronic media and the general listening public to pay their spectrum licence fees on or before the 30th November 2009. NATCOM will take appropriate measures to recover all monies owed to this government telecommunications watchdog in fulfillment of its mandate.

Somalia: IFJ deplores upsurge of attacks against journalists and media houses in Somalia

The International Federation of Journalists (IFJ) has condemned the upsurge of attacks against journalists and news media organisations in Somalia.

The IFJ condemns the grave press freedom violations that have been committed by Al-Shabaab extremist group in Kismayo, Baidoa, Bardhere and Mogadishu.

According to the IFJ's Somalia affiliate, the National Union of Somali Journalists (NUSOJ), Al-Shabaab says there have been a number of oppressive edicts that the extremist group wants the media to implement. Radio Warsan and Jubba Radio in Baidoa are closed since 21 October 2009. Currently the compound of Radio Warsan is being occupied by the Al-Shabaab armed men.

The IFJ says these edicts are unacceptable and restrict the work of the media in Somalia. "We fully back the position of NUSOJ. These interventions are intolerable and have the effect of intimidating independent journalism," said Aidan White, IFJ General Secretary.

Six journalists in Kismayo were forced to flee their town after they received from Shabaab threats ranging from arrest to expulsion working independently and reporting what is going in Kismayu. A number of media houses in Mogadishu and Bardhere have been intimidated by Shabaab. There have been statements from politicians and diplomats saying the media in Somalia was "influenced" and is thus "compromised" by Shabaab.

"Our Somali colleagues and their media houses are doing everything they can to operate in line with their profession in the face of deadly violence," said White. "We will give them full support against this deplorable intimidation."

Kenya: Kenyan minister accuses radio of airing partisan reports

Tourism Minister Najib Balala has accused a radio station of waging a campaign against him. Mr Balala accused the station, owned by the family of former Mvita MP the late Shariff Nassir and managed by Mr Abdulswamad Nassir, of using the station, Radio Rahma, to challenge him politically. The young Nassir has shown interest in wresting Balala for the Mvita seat.

The fresh war between Balala and Nassir started after a reporter from the station allegedly sought to interview the minister at a Mombasa hotel. "Tell your boss to come out in the open if he wants to play politics instead of using his radio station. I will beat him with his radio," Balala said.

The Standard could not establish what programme aired by Radio Rahma angered Balala. [Passage omitted: unrelated]

Namibia: 'Unequal Party Coverage Bad for Elections'

NEWS coverage of political parties by the NBC is continuing to irk opposition parties in the run-up to next week's elections.

The Nudo Party Youth League Secretary, Pro Laste Ngueumenga, last week told *The Namibian* that the NBC has been unfair in its radio and television coverage, denying voters equitable access to what each party has to offer.

"In the news each day, only one party is making all the headlines," he said, adding that this could encourage voter apathy.

"We would like to see change so that enough time is given for each political party," he said.

"If the ruling party is trying to block people's views via radio, television, or newspapers funded by the Government, at the end of the day we may observe that elections may be free, but they definitely will not be fair," Ngueumenga stated.

He said equitable reporting on radio is especially important, as this is often the only news medium accessible to people in the rural areas.

The Institute for Public Policy Research (IPPR) yesterday reported that for the week of November 6 to November 12, Swapo increased its dominance of NBC political news coverage to 83 per cent - one per cent up from the week before.

Other parties that received some coverage on NBC news included the RDP with 8 per cent, APP with 6 per cent, DTA with 1,5 per cent, and Nudo with 1,5 per cent.

"NBC ranks the opposition as less newsworthy than Swapo," the IPPR said, expressing concern that this trend could be in breach of the SADC principles and the African Charter on democratic elections.

It said NBC television news was the most skewed news medium. The print media - including the state-owned New Era newspaper - covered several items about opposition parties that simply didn't make it onto NBC television.

The IPPR report also highlighted the order in which party items appeared in news broadcasts.

"The items on Swapo rallies tend to be screened in a bloc followed by one or two items about opposition activities or sometimes none at all."

It said an opposition party item preceded a Swapo rally only once on TV news.

The IPPR also noted that on average, NBC reports on Swapo items last 2,5 minutes, while those on opposition-related news only lasted 1,5 minutes.

The programme dubbed « La Voix de la Sentinelle (The voice of the watchdog) » is one-hour weekly religious programme. It is broadcast in two languages French and Fon which widely spoken in Southern Benin.

Media Foundation for West Africa (MFWA)'s correspondent reported that the sponsors of the programme, "Etoile brillante du Matin" (Shining Morning Star), a non-governmental organization and the host Valdave Emilia Dagnonhoueton have also been suspended from broadcasting or publishing any material in the country for six months.

The correspondent said the suspensions came after a public hearing in which the directors of the station admitted publicly that they had failed to live up to their professional responsibilities regarding the November 3 edition of the programme by not listening to the contents before it was aired. That particular programme was said to be critical to the administration of Benin's president Yayi Boni. During the programme, Valdave Emilia Dagnonhouéton stated that « finally, everything has come to light and we have all understood », in reference to the developments under President Boni's administration.

According to the HAAC, the statement by host was extremely serious and endangered national cohesion and peace, hence the ban.

MFWA is appalled by this vicious attempt at sabotaging media freedom and freedom of expression. We urge the HAAC to as matter of urgency lift the suspension and allow the media and citizens to operate freely without fear of intimidation.

Somalia: Moderate Islamists ban residents from listening to "biased" station

The Ahlu Sunna wal Jama'a administration which is in control of most parts of Galguduud Region [central Somalia] has imposed restrictions on one of the independent radio stations operating in the country.

The spokesman for Ahlu Sunna wal Jama'a, Abdullahi Abdirahman Abu Yusuf, who is in Guriceel, Galguduud Region has accused Voice of Peace Radio of broadcasting reports that are hostile towards their group.

"We have prohibited people from listening to the Voice of Peace Radio in areas that are under our control. This is because it has on several occasions now broadcast reports that are meant to divide our group," said Shaykh Abu Yusuf. The official said Ahlu Sunna wal Jama'a forces will hold all media outlets accountable and any found to be engaging in appropriate activities will be banned. Employees of Somali media in general have been the victim of killings; imprisonment and constant harassment from groups that are fighting in the country some of them directly attacking journalists and offices of media organizations. The group also issued orders banning watching of films in the town and urged drivers of public transport vehicles to slow down when passing through the town centre so that they do not knock down residents. Ahlu Sunna wal Jama'a has also banned watching of Somali films saying that they are responsible for the collapse of many Somali families.

DRCongo: JED deplores ANR raid on Mbuji-Mayi station, assault of staff

On 12 November 2009 at 7:00 a.m, a group of officers from the National Intelligence Agency (Agence nationale des renseignements, ANR) and the Congolese Intelligence Services (Direction générale des renseignements des services spéciaux, DGRS) broke into the studios of Radiotélévision de l'Eglise évangélique libre d'Afrique (RTEELDA), brutalising journalists and other employees in the studio. RTEELDA is a religious broadcaster based in Mbuji-Mayi.

Jeef Tshidibi, Joseph Kongo and Tosta Ngoyi, the RTEELDA director, head of programming and technician, respectively, were arrested and questioned at ANR offices for almost 10 hours.

RTEELDA is accused of criticising Kasai-Oriental Governor Alphonse Ngoyi Kasanji during the broadcast of the show "Tuibakayi Kasai" ("Building Kasai"). According to the broadcaster, the host of the show was speaking about the deteriorating conditions of urban roads.

Contacted by Journaliste en Danger (JED), Tshidibi said they were summoned by the intelligence services to deliver the host, Vincent Tshamala, who has since gone into hiding. [...]

Namibia: Namibia's state broadcaster gives ruling party "lion's share" of poll coverage

The NBC slightly increased its election coverage of the opposition last week - a move political analysts believe could have been motivated by the presence of international election observers. Swapo still gets by far the lion's share with a whopping 70 per cent, but it is down from the previous week's 83 per cent.

The Institute for Public Policy Research's weekly monitor of TV broadcasting coverage of the elections shows that in the week of 13 to 19 November, coverage of the RDP by the national broadcaster improved from eight per cent in the previous week to 12 per cent in the week under review. But opposition parties in general are still receiving minimal coverage.

The IPPR also observed that on the Wednesday, November 18, the NBC gave Swapo the same amount of coverage it gave all the opposition parties combined.

This could have been coincidental but on that specific day SADC election observers arrived in the country.

On that day Swapo rallies got four minutes of coverage, followed by the RDP and Swatu each getting two minutes.

Several opposition-related stories featured in other media did not make it onto the NBC news. Among these was a panel discussion on inequality involving most registered parties, a CoD press conference on allegations of vote rigging, a Republican Party rally at Katima Mulilo, a Nudo rally at Opuwo, an RDP press statement on comments made by Swapo Vice President Hage Geingob, a CoD rally at Katima Mulilo, an RDP rally at Ondangwa and an RDP press release on repeat voting. The monitoring has also revealed that it has become harder to distinguish between some Government events and Swapo rallies.

There were two events covered on television news in the week under review which appeared to concern the launch of Government projects, but speakers wore Swapo colours and in one instance urged those attending the event to vote for Swapo.

The two events were the launch of a new road in the Omusati Region and the launch of the Omuthiya hospital project.

One Africa's coverage of the election dipped to 22 minutes from 30 minutes the previous week. Swapo and the CoD were the only parties to receive dedicated items, although most of the parties were briefly featured in an item on a panel discussion about inequality.

South Africa: South African government approves loan for national broadcaster

The Minister of Communications General (Ret) Siphiwe Nyanda is pleased to announce the approval of a bank guarantee for the South African Broadcasting Corporation (SABC) by government.

The Minister of Finance Pravin Gordhan approved the Public Broadcaster's application for a government guarantee of R1.473 billion [Rand].

National Treasury has stated that the guarantee will be released in tranches, with a draw-down of R1b made available immediately. Through newly introduced tight control measures that include regular management reports, the shareholder will ensure that the money given to the Public Broadcaster is utilized properly and to settle urgent outstanding financial obligations.

The release of the remaining R473m will be subject to the development of a detailed project plan by the Public Broadcaster committing itself to explicit revenue targets and cost cutting measures to enable effective oversight and monitoring of projections by government.

These undertakings will be included in the Shareholder Agreement between the Minister of Communications and the SABC board. [...]

Ghana: Police Officer Sues Joy FM, Two Others<http://allafrica.com/stories/200911270758.html>

A police officer at the Tema Newtown Police Station in the Greater Accra Region, has sued two private radio stations and a television network, for damaging his reputation.

L/Cpl. Ernest Alorli, alias Donkor, has filed a writ against Meridian FM, Joy FM and TV3 Limited, for dragging his name in the mud.

The plaintiff is therefore seeking damages in the sum of GH¢600,000, jointly and severally, against the defendant companies, in addition to cost.

In his statement of claim, the plaintiff indicated that in August this year, the defendant companies broadcast that "one Ernest Alorli alias Donkor, a policeman stationed at Tema Newtown Police Station, had been arrested for supplying assault rifles to armed robbers for their operations."

According to the plaintiff, the said broadcast attracted a lot of public condemnation, which subsequently impugned his reputation among members of the society.

L/Cpl. Alorli pointed out that the defamatory words carried on the networks of the defendant companies, impute dishonest and treacherous conduct and a dint of criminality, which attracts a very high sentence.

Plaintiff, who pointed out that he had suffered irreparable damage as a result of the actions of the defendant companies, further indicated that he had since the broadcast of the news item, been "shunned and avoided by members of his community, including his good old friends," adding that the actions of the defendant companies had brought him into public odium.

Zimbabwe: MDC Has No Authority to Shut Down External Radio Stations<http://allafrica.com/stories/200911270564.html>

Negotiators of the three main political parties in the inclusive government have been meeting to try to break the stalemate that is threatening to completely collapse the already shaky Global Political Agreement.

On Thursday the state controlled Herald newspaper quoted one of the negotiators, Professor Welshman Ncube from the MDC-M, saying the group had been discussing the same issues - "the appointment of Reserve Bank Governor and Attorney General, sanctions and pirate radio stations." The external radio stations, London based SW Radio Africa and Voice of America's Studio 7, are forced to broadcast from exile because there is no free media in Zimbabwe and independent radio is not allowed. The only broadcaster is ZBC, which is 100% controlled by the State.

Political analyst Professor John Makumbe said instead of talking about establishing democratic reforms, the politicians are as usual wasting time while the country is standing still. The MDC has also come under fire for agreeing to the ZANU PF demands to shut down private radio stations.

Makumbe said: "It is obvious that the MDC will never be able to stop the external radio stations - which are operated by Zimbabweans - from operating because they didn't set them up in the first place."

"They are not financing them, they are not funding them and they are not programming them. They have no authority whatsoever over these radios."

Professor Makumbe said ZANU PF is using the sanctions and radio stations issues as a way of stalling the implementation of the GPA and also as a way of denying the MDC their demands, including the swearing in of provincial governors.

He said ZANU PF should implement the outstanding issues first, if it wants western countries to remove 'sanctions' and also open up the air waves to allow other players in. While the politicians are concentrating on shutting down external broadcasters, they have failed to put the Media Commission in place, even though interviews for the commissioners have already been done. Furthermore, the political analyst pointed out that the ZBC is still broadcasting in a partisan manner in favour of ZANU PF and denigrating the MDC and that there is still a lot of hate speech. Makumbe said the government is the one 'imposing sanctions' by forcing Zimbabwean radio stations to operate from outside.

Meanwhile, the Herald reported that South Africa President Jacob Zuma has appointed a new team to monitor Zimbabwe's fragile government. The team consists of the President's political advisor Charles Nqakula, Zuma's international relations adviser, Lindiwe Zulu and special envoy Mac Maharaj.

Makumbe believes this is a strong team of senior ANC and government officials and that they are likely to make positive inroads, unlike the mediation by former SA President Thabo Mbeki, who he said was a 'very slow man who majored in quiet diplomacy and was clearly partisan in favour of

ZANU PF.'

Kwabena Ntow, reporter de Fila FM, une station de radio privée basée à Tamale, et correspondant de Peace FM, une station de radio basée à Accra, pour avoir prétendument fait un reportage tendancieux contre leur club.

En confiant la rude épreuve qu'il a subie à la Fondation pour les Médias en Afrique de l'Ouest (MFWA), Ntow a affirmé que l'incident a eu lieu au stade omnisport de Tamale, où il s'était rendu couvrir un match de championnat entre RTU et Wa All Stars.

Selon le journaliste, l'un des supporters, en présence du secrétaire du club, M. Joe Harry Dua Baba, l'a passé à tabac et l'a blessé au menton.

"Je me suis rendu à l'entrée du vestiaire pour mener une interview après le match. C'était à ce moment que l'un des supporters m'a affronté et s'est mis à me tabasser. Ils ont prétendu que je fais des reportages tendancieux contre leur club. C'était le président de RTU et l'entraîneur en chef,

Abdul Razak, qui sont venus à mon secours en m'envoyant dans le vestiaire". Le journaliste a prétendu que dans le vestiaire, Dua Baba a justifié l'action menée par les supporters en l'accusant de reportages tendancieux contre le club. Quand la MFWA a pris contact avec M. Joe Kadil, le président de RTU, il a confirmé avoir sauvé le reporter de la colère des supporters. Il a ajouté que le club n'en veut aucunement à Ntow. Le gouverneur de Louga, El hadji Diallo, a procédé mercredi au lancement du feuilleton radiophonique de la RTS "Ngelawu Nawet" (vents d'hivernage) devant aider à améliorer le statut sanitaire des familles et à faire la promotion sociale du changement de comportement. Il s'agit par conséquent d'une action de développement qui doit être soutenue par toutes les bonnes volontés, a relevé le gouverneur souhaitant que les autres médias se l'approprient pour le service exclusif des populations.

En appuyant ce projet, l'USAID entend soutenir l'Etat dans sa volonté d'atteindre les Objectifs du Millénaire pour le développement(OMD), réduire la mortalité maternelle et infantile, et combattre le paludisme, la tuberculose, le SIDA, etc., a indiqué le conseiller en santé de l'USAID, Joshua Karnes. Les émissions seront diffusées les mardi, jeudi et samedi entre 21 heures et 21 heures 30 minutes, a précisé le chef de la station régionale Saliou Ndour, assurant que les conseils de quartiers créés par la municipalité seront fortement impliqués dans le déroulement du programme.

Ce feuilleton en langue wolof de 168 épisodes devra faire la promotion sociale du changement de comportement, à travers une approche éducation/divertissement innovante utilisant la radio comme support, et augmenter la réceptivité des comportements sains ciblés pour appuyer la stratégie du Programme santé.

L'initiative est soutenue par l'USAID et l'ADEMAS. D'une durée de 14 mois, le feuilleton sera suivi, à chaque fin de semaine, par l'organisation d'un plateau interactif avec appel d'auditeurs, lit-on dans la note de présentation.

RDC : JED dénonce l'utilisation abusive de l'ANR dans une affaire de presse à Mbuji-Mayi

Journaliste en danger (JED) demande au gouverneur du Kasaï oriental, M. Alphonse Ngoyi Kasanji, de mettre fin à l'utilisation abusive des services de l'Agence nationale des renseignements (ANR) pour traquer des journalistes et médias qui le mettent en cause. "Aucun texte de loi en RDC ne donne mandat à l'ANR pour connaître des infractions commises par voie de presse", a déclaré JED qui estime qu'il s'agit d'un abus de pouvoir qui doit prendre fin.

Selon les informations concordantes recueillies par JED, un groupe d'agents de l'ANR/Kasaï oriental et de la Direction générale des renseignements et des services spéciaux (DGRSS/Kasaï oriental) ont fait irruption, jeudi 12 novembre 2009 à 7 heures du matin, dans les salles de rédaction et studio de la RTEELDA (Radiotélévision de l'Eglise évangélique libre d'Afrique), brutalisant les journalistes et les autres personnes trouvés sur le lieu.

Jeef Tshidibi, Joseph Kongo, Tosta Ngoyi, respectivement directeur, chef des programmes et technicien de la RTEELDA, ont été interpellés et conduits à l'ANR où ils ont été entendus sur procès verbal pendant près de 10 heures.

Il était reproché à la RTEELDA d'avoir diffusé le même jour l'émission "Tuibakayi Kasai" (Construisons le Kasai), dans laquelle le journaliste aurait, selon l'ANR, critiqué M. Alphonse Ngoyi Kasanji, gouverneur de la province du Kasaï oriental et pourtant, selon la rédaction, dans cette émission, le journaliste parlait de la dégradation de la voirie urbaine.

Contacté par JED, M. Tshidibi a déclaré qu'ils ont été sommés par les services des renseignements de livrer le journaliste Vincent Tshamala qui est entré en clandestinité depuis lors.

Cela s'est passé dans la nuit de lundi 23 novembre 2009 aux environs de 20h00 en commune de Kadutu, quartier Camps Cinéma-Mulikuza à quelques mètres de son domicile.

Tout à commencé lorsqu'en passant Trésor ILANGA a vu surgir d'un coin de la route quatre hommes qui l'ont arrêté en s'exclamant: «Voilà le journaliste ! Eh Monsieur arrêtez-vous !» Après ils lui ont demandé de montrer sa carte, le journaliste refusera. C'est ainsi qu'il a crié et les quatre hommes se sont jeté sur lui, l'ont roué de coups et ravis ses équipements (enregistreur, téléphone et montre) après l'avoir renversé dans un caniveau, ses bourreaux se sont volatilisé dans la nature. Suite aux cris du journaliste, les passants sont venus intervenir alors qu'il saignait déjà au niveau du front et l'oeil droit. Il sera conduit la nuit même à l'hôpital où il suit les soins. A bout de souffle, les journalistes de Bukavu en général demandent aux autorités civiles et militaires d'assurer leur sécurité. Car il ne se passe deux mois sans qu'un journaliste ne soit agressé dans la ville de Bukavu.
